The Garden Ridge City Quarry Commission will meet in regular session on Monday, July 18th, 2011 at 7:00 p.m. in the City Council Chambers, 9400 Municipal Parkway, Garden Ridge, Texas. This is an open meeting, open to the public, subject to the Open Meetings Law of the State of Texas, and as required by law, notice is hereby posted on or before July 15th, 2011 before 5:00 p.m., providing time, place, date and agenda thereof. The meeting facility is wheelchair accessible and accessible parking spaces are provided. Requests for accommodations or interpretative services must be made 48 hours prior to this meeting.

Rules for Citizen's Participation:

The Quarry Commission welcomes citizen participation and comments at all of their Commission Meetings. As a courtesy to your fellow citizens and out of respect to our appointed officials, we must request that if you wish to speak, that you follow these guidelines.

- a. Direct your comments to the entire Commission, not to an individual member, nor to the audience.
- b. Show the Quarry Commission the same respect and courtesy that you expect to be shown to you.
- c. Limit remarks to three (3) minutes.

*NOTE: The Texas Open Meetings Act permits a member of the public or a member of the governmental body to raise a subject that has not been included in the notice for the meeting. However, any discussion of the subject **must be limited** to a proposal to place the subject on the agenda for a future meeting and any response to a question posed to the Quarry Commission is limited to either a statement of specific factual information or a recitation of existing policy. TEX. GOV'T CODE § 551.042.*

6. New Business / Discuss and Consider Action On:

a. Review previous month's blast.

Review and discussion of the monthly Hanson Quarry blasting analysis data reported by Joe Crownover of Vibratex. Discussion with Ken Early of Hanson Servtex and Blasting contractors, on recent quarry operations, including any unusual blasts that occurred last month.

b. Follow up, as necessary, on reports: Texas House bills (Blades); Mental health issues as they might relate to quarry operations (Mudge); citizen complaint process, follow up and citizen mailings (Mudge, Holly); Commission accomplishments (Warden, Gunnarson); Damage report form and follow up procedure (Mudge); What the commission can better do to support and communicate with the citizens of Garden Ridge (Holloway). What is next?

c. Discuss public meeting and the possible integration of this with the City public meeting on Ordinance 34.

d. Discuss ORD 34 distance recommendation and other environmental issues.

e. Discuss Grapevine article and monitor locations.

f. Discuss Ed Ford's comments before City Council as they reference ORD 34 and quarry blasting operations.

7. Review individual citizen complaints and quarry commission member contact, as necessary.


