AGENDA CITY COUNCIL SPECIAL MEETING TUESDAY, MAY 14, 2019, 6:00 P.M.

The Garden Ridge City Council will meet in a special session on Tuesday, May 14, 2019, at 6:00 p.m. in the City Council Chambers, 9400 Municipal Parkway, Garden Ridge, Texas. This is an open meeting, open to the public, subject to the Open Meetings Law of the State of Texas, and as required by law, notice is hereby posted by May 11, 2019, before 6:00 p.m. providing time, place, date, and agenda thereof. The meeting facility is wheelchair accessible and accessible parking spaces are provided. Requests for accommodations or interpretative services must be made to the City Secretary 48 hours prior to this meeting.

5. Citizen Comment Period – limited to 30 minutes total

Rules for Citizens' Participation:

The City Council welcomes citizen participation and comments at all City Council Meetings. The City Council offers citizens the opportunity to address them by signing up to speak prior to the meeting. If you speak, you must follow these guidelines:

- a) Respect and courtesy:
 1. Direct your comments to the entire City Council, not to an individual member, nor to the audience.
 2. Show the City Council the same respect that you would like to be shown.
 3. End your speaking at the time allotted below.
- b) Speaking:
 1. First citizen comment period
 - 1.1. You are required to sign up to speak and you are limited to one 3-minute period.
 2. Business item period
 - 2.1. You are required to sign up to speak and you are limited to one 3-minute period.
 3. Second citizen comment period
 - 3.1. You are not required to sign up and you are limited to one 2-minute period.
 4. State your name and address before your comments begin.
 5. You are only allowed to speak once per topic, unless also speaking during a posted Public Hearing.

NOTE: The Texas Open Meetings Act permits a member of the public or a member of the governmental body to raise a subject that has not been included in the notice for the meeting. However, any discussion of the subject must be limited to a proposal to place the subject on the agenda for a future meeting and any response to a question posed to the City Council is limited to either a statement of specific factual information or a recitation of existing policy. TEX. GOV'T CODE § 551.042.

The following items are for discussion, consideration, and action.

- a) Canvass the results of the May 4, 2019, General Election of the City of Garden Ridge, Texas, and declare the results of said election.
- b) Councilmember Closing Statement (Erickson).

- c) Issue Certificates of Election and Administer Oaths of Office to Larry Thompson for Mayor, Lisa Swint for City Council Place 2, and Bryan Lantzy for City Council Place 3.
- d) Election of Mayor Pro-Tem for a one-year period expiring May 2020.
- e) Designation of authorized signers on bank accounts held by the City of Garden Ridge with First United Bank and TexPool.
- f) Announcement of reception honoring Councilmember Erickson immediately following adjournment.

Action by Council Authorized:



Executive Sessions Authorized:

This agenda has been reviewed and approved by the City's legal counsel and the presence of any subject in any Executive Session portion of the agenda constitutes a written interpretation of Texas Government Code Chapter 551 by legal counsel for the governmental body and constitutes an opinion by the attorney that the items discussed therein may be legally discussed in the closed portion of the meeting considering available opinions of a court of record and opinions of the Texas Attorney General known to the attorney. This provision has been added to this agenda with the intent to meet all elements necessary to satisfy Texas Government Code Chapter 551.144(c) and the meeting is conducted by all participants in reliance on this opinion.


Attendance By Other Elected or Appointed Officials:
